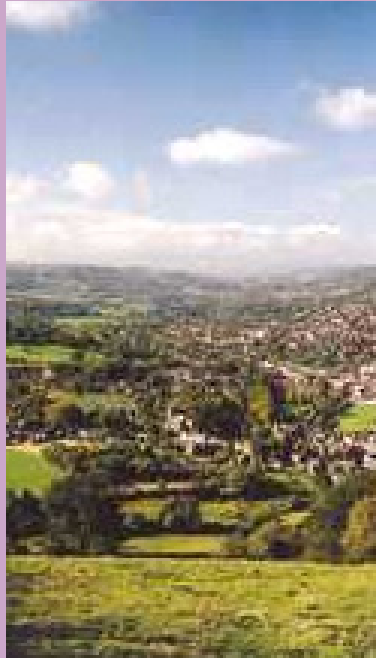
Government Aims

- Putting patients and the public first
- Improving healthcare outcomes

- Cutting bureaucracy and improving efficiency



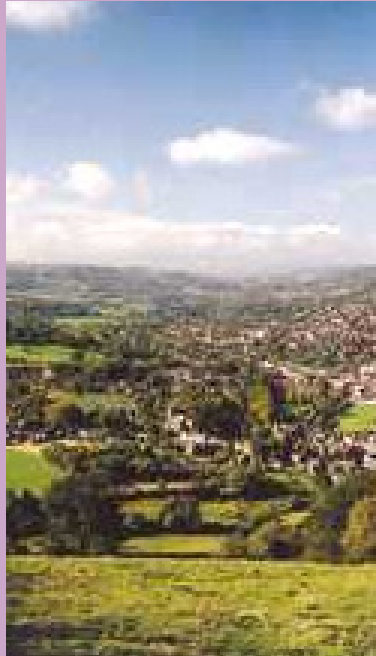
What will happen (from April 2013)

- Abolition of SHAs and PCTs
- Creation of:
 - NHS Commissioning Board
 - Public Health England
- GP led commissioning (Clinical Commissioning Groups)
- Public Health to transfer to County Council
- Health and Wellbeing Boards established



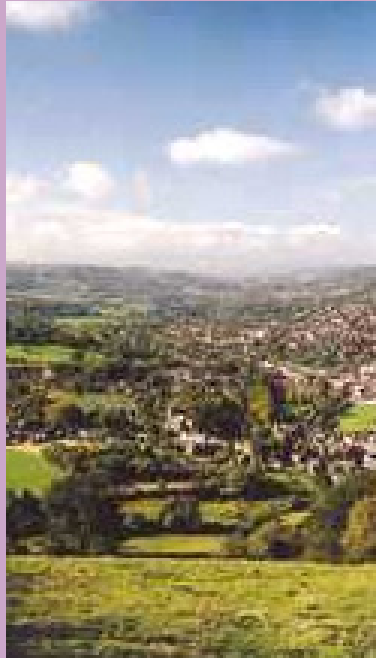
In More Detail

- Clinical Commissioning Groups will take on most of the PCTs current responsibilities
- NHS Commissioning Board will hold CCGs to account
- Public Health England will be created within DoH
 - Health Protection
 - Intelligence and Information
 - Administer Public Health Grant (including Health Premium)
- County Council
 - Responsible for health improvement and reducing health inequalities
 - Some treatment services
 - Oversight of commissioning
 - Will receive ring fenced Public Health Grant
 - Must establish Health and Wellbeing Board



Health and Wellbeing Boards - Role

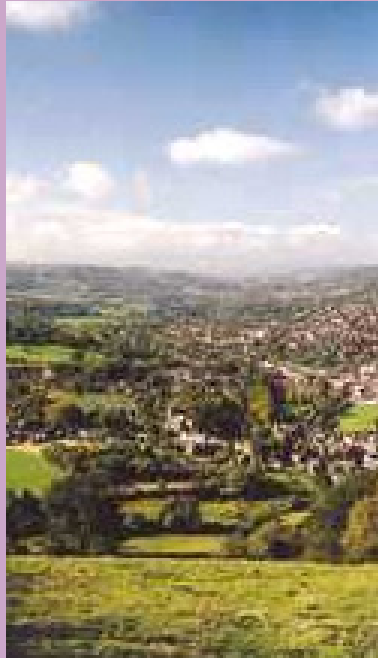
- Joint Strategic Needs Assessment
- Joint Health and Wellbeing
- Emphasis on Joint Commissioning and integrated provision between health and social care
- Ensure that CCGs commissioning plans are in line with the Strategy
- Lead on public involvement
- Committee of the County Council
- Subject to statutory arrangements for scrutiny

- PCT Cluster

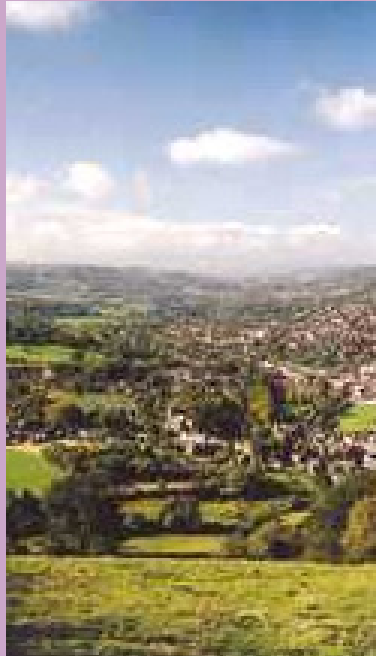
- Derbyshire “early implementer”

- First meeting 7 July 2011



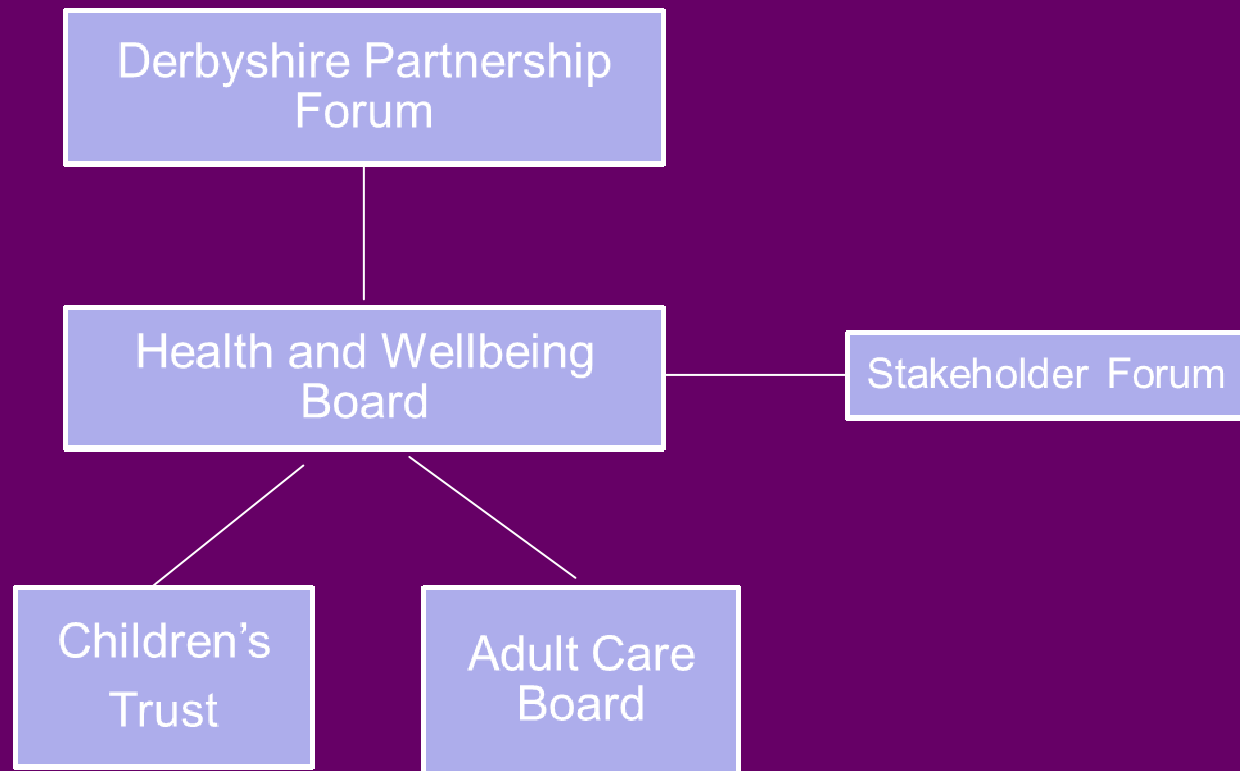

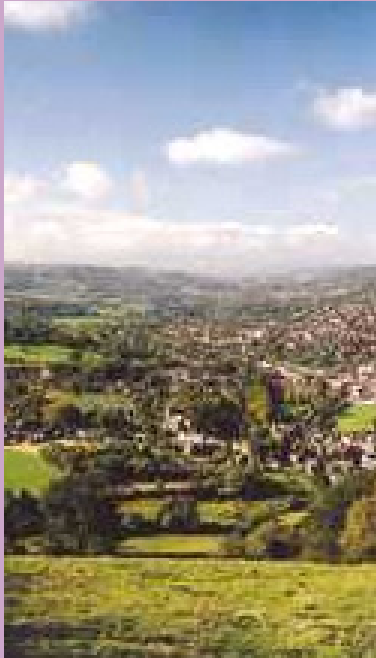
